

CONTEST RULES "FreeGalaktus 2017"

I. GENERAL RULES

§ 1

These regulations specify the conditions under which competition "FreeGalaktus" takes place, hereinafter referred to as the "Contest". The object of the contest is to select three best indie games, one in each of the categories.

§ 2

Competition is organized by Galaktus PR agency, located at ul. Jagiellońska 57, 15-250 Białystok, Poland ("The Organizer") and www.adoptmygame.com website.

§ 3

The competition is organized on Polish territory, on the Organizer website <http://www.freegalaktus.pl/> and on the Facebook profile = <https://www.facebook.com/galaktusPR>.

§ 4

The competition runs from 12.09.2017r. to 30.11.2017r.

II. COMPETITION PARTICIPANTS

§ 5

The participant of the Contest may be a person or group of persons or companies that create their own video games. To participate in the contest, participants must submit a brief presentation which contains materials relating to their game hereinafter called "Contest Submission" on the register form website of the FreeGalaktus : (<http://freegalaktus.pl/register-form/>).

§ 5.1

"Contest Submission" (<http://freegalaktus.pl/register-form/>) must include:

Game info:

- Game title
- Short description (400 characters max - spaces included)
- Movie link 1 (vimeo or YouTube)
- Game Website URL
- Types of game
- Game Status
- Platforms (PC, Console/Mobile,VR)

Information about the developer:

- Company name
- City
- Country
- What your company needs

Images:

- Game Logo: best ratio 16:9, min 800 px width
- 4 Screenshots: best ratio 16:9, min 800 px width

§ 6

The participants of the competition cannot be employees or persons remaining in respect of the order or other legal relationship to which the provisions of the order with the Competition Organizer and family members of the persons, to the second degree.

§ 7

Organizer takes responsibility for processing the Personal Data. Personal Data provided to the Organizer for the Competition will be processed only for the purpose of the Contest. Personal data

can also be processed when it is necessary for the legitimization purposes. Providing personal data is voluntary, but they do not prevent the administration of the winners to receive prizes.

§ 8

Entrants have the right to access their personal data and editing.

III. RULES AND COMPETITION

§ 8 1.

In order to maintain the proper conduct of the Contest, selecting the best games and the award of prizes, the Jury, appointed by the organizer, will be making sure rules are respected. The jury includes one person from the Galaktus Agency and 4 experts from gaming industry. Juror cannot give points to the production he is linked to in terms of business publishing, producing, developing or in any other way.

8 § 2.

The main competition consists of one stage: 12.09.2017r. - 24.11.2017r. - Reporting to the Competition by sending competition presentation with information about the game via email, among which the jury will select the one best application. The second game will be selected based on voting by Internet voting form "People's Choice", which will appear on the competition's website. Voting online lasts between 04.09.2017r to 30.11.2017r.

§ 9 1.

1. To enter the competition, you must:
 - Create, or be in the process of creating your own video game for the PC platform / Android / iOS
 - Become familiar with the Rules of Competition
 - Submit an application by e-mail (free@galaktus.pl or m.greloch@galaktus.pl) containing a file with information about the game
 - Accept, that the game will also be added to the AdoptMyGame website.
2. Submitted games cannot contain links, phrases deemed offensive or in any way detrimental to the feelings of others. Texts containing the above will be immediately expelled from the competition.
3. The Challenge the participants are facing is to submit the best game they created.
4. The Competition rewards the best, most imaginative and original work. One game by the jury and the second by Internet users.
5. The competition is conducted in three categories: PC, Mobile/Console, VR and one additional: People's Choice. In the main categories, winner is selected by the jury. In the category of People's Choice, winner is selected among Internet users.
6. The condition for participation in the Competition is to submit an Application from 04.09.2017r. to 17.11.2016r and its acceptance by the moderators.
7. Each of the Participants of the Competition can only submit 1 application.
8. The application will be included on the website within 24 hours after checking its correctness.
9. If the game for which the application has been submitted is already ready to buy for more than 6 months, the corresponding annotation will be placed next to the content submitted presenting the game.
10. By participating in the Contest, the Entrant acknowledges and agrees that the submitted game is of his authorship and that he has the required copyrights including the right to send it to the competition.

11. Organizer specifies that all forms of unfair competition (including spamming on the Facebook and other websites, sending the game created by someone else), aimed at cheating in the competition, are prohibited. Thus, in appropriate cases, when one of the participants is to be found guilty of such practices, the Organiser has the right to remove the application from the Contest.

12. The results of the Competition will take place on 01.12.2017 on the www.freegalaktus.pl website and on the FB profile of the Galaktus PR Agency at <https://www.facebook.com/galaktusPR>

13. Names of winners (according to data provided by the participants during the reporting online game) will be published on the profile of the Galaktus PR Agency at <https://www.facebook.com/galaktusPR> by a person appointed by the organizer.

If the leader fails to contact until the 5.10, 12:00 AM) the offer will be redirected to the studio occupying the next place in the poll.

V. FINAL PROVISIONS

§ 11

1. Notification of participation in the Competition requires the Participant's consent to publish some of the data listed in § 9 (in particular the name) in all materials, regardless of

their form of expression, with the object of promoting competition and relations with its course at www.facebook.com/GalaktusPR and www.adoptmygame.com by the time specified by the Organizer.

2. Organizer does not bear the costs associated with the delivery of competition entries by the participants of the contest.
3. The organizer bears the costs of delivery of prizes awarded in the Contest.
4. The organizer reserves the right to not exchange the prize for cash equivalents.
5. The organizer reserves the right to change the dates of: start and stop submitting the competition entries, the start and end of voting and the publication of the results of the contest.
6. In case of violation of the Rules (in particular Point II.6, Point III.10, III.11 Point) by the Participant, Responsible Persons appointed by the organizer may exclude it at any stage of the competition, even after the announcement of the results.
7. In matters not regulated herein, the provisions of the Civil Code take place.

9. Application to the competition constitutes acceptance of the conditions set in the Regulations and the submission to the www.adoptmygame.com.
10. The organizer informs that the contest is in no way sponsored, supported or carried out by the service Facebook or related to it.
11. The website Facebook.com does not help in the conduct of the Contest. Competition Organizer uses Facebook to administer the competition at their own risk.
